 - a. Oversight of Significant Town Owned Open Space properties

Springdown. Young and Dennis attended our meeting tonight to hear about our plans for Springdown and to make sure we followed proper procedures. Dennis encouraged us to look at all the open spaces as a whole, which we have been doing for years. The Town is supportive of our efforts and urges us to create an overall plan for Springdown. We plan to do this and take it to the Council for their input. More immediately we are encouraged to move forward with plans for a test plot of weed elimination and wildflower seeding. We hope to fast track this because the fall rains are approaching and late October/early November is the optimum timing. Work on the vernal pond is expected to be completed 10/31/17; we would like to start shortly after that. Subcommittee report is Appendix A. Motion by Chiariello, seconded by Plunder: Conservation Committee endorses the expenditure of up to \$10,000 by the Open Space Fund to begin phase 1 of the Springdown restoration. Unanimously approved. Dennis also encouraged the committee to develop a comprehensive set of plans for all open space properties.

- iv. Town Center report by Murphy and Chiariello see Appendix B. Dennis appreciates the explicit enumeration of outstanding attributes.
- v. ROW dying ?oaks on Portola near Santa Maria. Young had McClennahan evaluate. They agree with several of our members that the heat of the asphalt led to leaf death. The trees should recover nicely. In the course of this inspection, an oak dying of SOD was discovered. It was removed taking proper precautions.

- f. Committee/Town cooperation
 - i. Public Works. Young reports
 - 1. Springdown work on pond restoration is underway. Woodrats have been relocated, brush selectively cleared and the pond drained. After drainage it refilled about 2 feet; after drained again, it again refilled itself to about 1 foot. It is not clear what the source of this water is a spring or a connection to the upper pond, or something else. Reshaping of the dirt to create a more gentle bowl is underway. Friday 10/6 we are invited to come look at progress and make suggestions if we see anything additional needed improvements. It is anticipated the entire job the final steps are surrounding weed control and hydroseeding and woodrat return- will be completed by 10/31

- The re-sprouting eucalyptus at Portola/Westridge were stump ground out.
- More trees than usual have fallen in town in the last few months, so his department has been busy clearing these. Significant brush clearing in ROW as requested by Fire Department has also been done.
- 4. He is preparing to spray for SOD prevention the significant trees on town center and in ROW. At Plunder's request he will add 5 trees along Shady Trail. Plunder will mark them.
- ii. Town Center master Plan Committee no report
- iii. Sustainability and Environmental Resources (previously Water Conservation) Committee They are planning to again produce a PV Garden Tour focused on native and low water use gardens since this was such a success last year. deStaebler and Murphy will be this committee's representatives to the planning committee.
- iv. Dennis and Young clarify for us the recent snake encounter on Town fields. A snake was found by soccer parents on Rossotti field. Concern was great that it might be a rattlesnake, although it was determined to be a gopher snake. A few days later another snake also a gopher snake was found by Town staff while maintaining the field. It was relocated to the hills. Increased maintenance of the field including mowing of the sideline areas and repeated probing of the area of the stands was done. The soccer league lawyer contacted the Town and Dennis has solicited advice from several sources including CountyVector control and Jasper Ridge. All say that although rattlesnakes are found in town they are much more likely to be in drier areas. The gopher snakes are an important part of local fauna and help control the gophers. Conservation encourages increased education about gopher snake identification to decrease undue anxiety and increase understanding of the value of gopher snakes.

- g. Weed seedling info sheet photos labeled Plunder will find new more easily identifiable photos. Time goal is February when information most valuable to residents.
- h. Fall Town evening on Rodenticides Chiariello reports on the details of plans for the evening. Dennis says Town staff will do the set-up, tear down and simple refreshments and will cost share the live raptors. Motion by deStaebler, seconded by Heiple: Committee approves expenditure of \$300 toward cost of live raptors at Rodenticide evening presentation. Unanimously approved.

Appendix A – Springdown subcommittee report

Members of the Springdown subcommittee: Jane Bourne Nona Chiariello Alex Von Feldt Grassroots Ecology Paul Heiple Gary Nielsen Open Space Committee Marianne Plunder (Chair)

The subcommittee has met several times in August/September to discuss the Conservation Committee's partial Springdown restoration and weed management project.

After a site visit and helpful input from Alex von Feldt and Howard Young the subcommittee decided to restore a 50 feet deep strip from the pond area up to Portola Road along the inside of the path:

the area is approx. 1 acre in size.

Action needed:

Conservation committee to approve the proposed expenditure of \$ 10,000.00 on 9/26/17

Buy Native CA Wildflower mix approx. \$ 400.00 Hire Go-Native \$ 9.600.00

- -manually dethatch the restoration area (October)
- -seed CA wildflower mix (October)
- -cut the weed clusters on the Sprindown site that have not been cut in 2017

Daily rate of \$1,600.00; approx. 6 days of work = \$9,600.00

The \$10,000 will come from the Open Space Fund, as proposed by Gary Nielsen.

The above described work will cover phase 1 of the partial restoration project. Phase 2 is to develop a comprehensive weed management plan for the whole Springdown site, as planting without weed control is futile.

Goals and oversight responsibilities are different from other Town owned open spaces because Town Center is more developed, more heavily used and is the public living room for the town.

Action Items: needs attention soon from the town:

- 1. Removal of the following plants
 - a. Small oak trees bed #15 and end of bridge bed #22.
 - b. Italian Buckthorn(?) at base of large oak bed #13
 - c. Willow bed #12
 - d. Fig bed #8 needs digging out, has been cut back before

Outstanding attributes:

- 1. The creek and its plantings
- 2. Excellent original planting plan emphasizing low water natives.
- 3. The view across the orchard to the western hills.

Native plants seen: See brochure

Any rare plants seen? No

Anything that needs protecting? Heavy use requires thoughtful placement of plants.

Heritage trees noted: Many through site

Invasives: Under good control by Go Native

Any current issues with this site or risks to the site:

- 1. The landscaping is aging and looks thin and tired in many areas. Beds should be rejuvenated by supplemental planting in the fall.
 - a. Plant choice should be guided by what has thrived here or nearby.
 - b. Priority areas for rejuvenation are #7, #11, #17 and flagpole area of #10
 - c. The following would be appropriate additions to the plant list:
 - i. Monardella
 - ii. Zauschneria/Epilobium
 - iii. Wyethia Mules ears
 - iv. Salvia spathyphyllum Hummingbird sage
 - v. Cygnoglossum grande Pacific Hound's tongue
 - vi. Hounds Tonque
- 2. Informal Paths of Use have destroyed some vegetation. These footpaths should be respected and cleared.
 - a. No planting should be done in these paths.
 - b. Where the whole area is repeatedly trampled (triangle between playground and creek bed#21), no planting should be attempted, weeds should be cleared and the area mulched yearly.
