Neighboring residents requested of Cal Water that old tall Monterey Pines be removed to unblock views, and screening of water tank from driveway opening be added. CalWater and neighbors designed a simple plan to remove the undesirable trees and plant large shrubs from Town approved list; work to be done at neighbors' expense. Committee approves the plan.
