## **Oral Communications:**

- Concerns raised and disappointment expressed over September 30th "PG&E in Portola Valley" webinar on wildfire preparedness, vegetation management and grid and equipment maintenance
- Concerns and discussion regarding Eucalyptus trees in town and potential for wildfires

**Approval of Minutes from September 3, 2020**: Approved as amended (9 Ayes, 0 Abstentions, 0 Noes)

# **CERPP/WFPD Report (Lindner/Brown)**

- Fire incidents in SMC are winding down
- No major updates to Zonehaven project. Process continuing. Feedback from town and residents incorporated. Some project resources are now involved in Glass fire which is having small impact in project timing
- COVID-19 update: no change to operations. Considering slow reopening of facilities. No uptick in infections
- Some involvement of local WFPD resources in Glass fire, and others around state
- Question concerning Zonehaven mapping and impact to the Sequoias
- October 4 10 is Fire Prevention Week. Theme is 'Fire Safety in the Kitchen'
- CERT all-hands webinar on October 24
- Applied for a CERT grant. If approved, money is provided on per resident engagement
- Next CERT committee meeting on October 21 (3<sup>rd</sup> Wednesday of month)

 WFPD's annual October flu vaccinations clinic will not happen this year due to the pandemic

# **Town Report (de Garmeaux)**

- Exploring virtual EOC options. Second vendor demo being scheduled
- Town is preparing for possible PSPS events
- Volunteers identified to evacuate IT equipment from town hall, if required, and a remote location to set up
- Advised that later this year, possibly in November, Town Council will review a new red flag ordinance proposal

# **Committee Reports**

- Medical Subcommittee (Shefren)
  - Continued work on liability issue raised in previous meeting. Talked extensively
    with county disaster worker program, Jeremy on town's liability policy, and Mark
    Dahlen on relationship to CERT program. Analyzing information and further
    research continuing. Report to Committee pending
  - Working with WPV-CERT committees. Have identified some extra COVID-19
     PPE that could be stored in supply lockers in PV (masks and gel)
- Communications Subcommittee (Rothrock)
  - Work on relocation of AM transmitter and antenna continuing. California Water Services (CWS) has put together a license and sent to Town for review. Relocation still requires power, phones, antenna planning. A full review including a budget proposal will be presented to the Committee shortly. There will also be a plan to maintain portability of AM radio system regardless of new location
  - Discussion on the need for a communications plan between CERT Incident Command Post and Town EOC
  - Cell tower power backup being tracked by Ad Hoc Wildfire committee
  - Question regarding how town residents can get vital information if internet is down. Explained that this is the purpose of Town's AM radio station
- Outreach Subcommittee (Duval)
  - o October monthly tips (Resilient Portola Valley) will focus on fire prevention topics
  - Suggestion from committee to have people check settings in SMC Alert given continuing upgrades of the system
- CERT/Town/Woodside Integration Subcommittee (Raanes)
  - Review Woodside EPC liaison (report or implement)
  - o Review CERPP/CERT board liaison
