- 1. Radio Communications Status
 - a. AM Radio. Fully operational.
 - i. Re license update.
 No response for the FCC. Checked on 2/1/21.
 Our STA with the FCC expired on Dec 22. We applied (June 2020) for permanent use of the 10W antenna arrangement. Exploring angles to get FCC to move.
 - b. PVARC amateur repeaters fully operational.
 - c. SM OES UHF link in PV fully operational.
 - d. WPV-CERT Portola Valley GMRS repeaters (PV1, PV2, PVT) fully operational.
 - e. WPV-CERT Portola Valley digital repeater fully operational.
- 2. AM Antenna Relocation Project
 - a. Standing by. Work being process by Town.
- 3. Easter Cross Repeater Project for WPV-CERT repeaters
 - a. Signed Everest Design to do the required and certified engineering work for this repeater system installation.
 - b. Working with Mark Dahlan to lay out the cabinet contents, researching interference potential, etc.
 - c. Hope to have working drawings to submit to RWC by end of February.

Emergency Preparedness Committee Outreach Subcommittee Report February 4, 2021

Annual metric of outreach subcommittee effectiveness: Last year we talked about measurable objectives for our committee. While adapting to covid changed our plans, our extended team (WPV-Ready, WPV-CERT, etc.) moved forward with zoom classes, etc. For in-person classes and safety meetings, attendance is carefully tracked with sign-ins and related info. Not so with zoom classes as yet. (It can be done, but our hard-working fellow volunteers across the district were particularly stretched this past year.) We will work to refine this tracking operation going forward and try to break out the 94028 residents.

2020 district numbers (very soft): About 60 did the hybrid online CERT Basic Training; about 40 in WPV-Ready Basics class; about 30 in CERT-level first aid kit organization class with more than 165 video views); fire resiliency in neighborhood had about 40 with another 63 video views. Of those "participants," about 40% from PV and 40% from Woodside. (Source: Chip Swan, CERPP)

Percentage of PV residents subscribing to SMCAlert is the highest in the entire county per SMC OES at almost 85%. (NB: Ongoing data gathering is occurring to clarify and fine time numbers. (SMC OES, January, 2021 report)

WPV-Ready/WPV-CERT Monthly Update January 2021

WPV-Ready

- The marketing subcommittee has been continuing forward and has now integrated with MPCReady (Menlo Park)
- The 2nd version of family first aid kits have been made and will be shipped in 2 weeks. The new price for kits will be \$1450.00 to cover the costs of items we replaced due to poor quality and to cover labor. We will be offering 20% discount coupons to pre-orders. This will be distributed in the coming week.
- We have finalized the inventory list for a 25-person first aid kit.
- We are working on 1-page (double-sided) information hot topic sheets that
 we can give to local community emergency preparedness leaders who want
 to disseminate information to their neighbors. Topics will range from
 evacuation to emergency notifications. We will also be creating webpages
 for each topic which will include other resources such as videos.
- We have begun assisting residents who want to become emergency preparedness (EP) leaders within areas of WFPD. It is apparent that the demographic areas known as "Divisions" has become difficult to manage for current Division Leaders as well as anyone who wants to step into a role as an EP leader. We have heard from some Divisions that they cannot effectively reach all residents with the current boundaries set forth. It has been identified that areas that have a Homeowners Association, Road Association, or other group that brings neighbors together can work to help dovetail emergency preparedness. Aside from that, we have decided that allowing areas or communities to organically form should be encouraged







and supported. Such as blocks, cul de sacs etc. For example, Old La Honda
has had an issue incorporating some residents at the bottom of the hill.
Chip Swan identified a couple of neighbors willing to step up into the role of
a community emergency preparedness leader. We are now working with
them to reach out to the other homes and have identified them as a new
community with EP Leadership.

WPV-CERT

- The CERT Hybrid course has finished its online component as of January. (for numbers pertaining to any of the trainings further, please refer to the Outreach Subcommittee Report). We are planning on holding regular meetings to continue to build camaraderie within the group until we can officially meet in person for the skills portion (date TBD).
- We continue to work on grant funding now that the enrollment period has been extended a few more months.
- We held training a command post training on January 16th, you can view the training on our Youtube Channel WPV-Ready
- We have scheduled training supplemental training for the February and March. February 27th we will have Craig Taylor as a guest speaker to speak about best practices and his personal experiences with the Search and Rescue Team. March will focus on animal safety/emergency preparedness pertaining to both large and small animals.

Woodside Fire Report February 4, 2021

<u>Covid-19/Vaccinations:</u> Number of positive cases continue to fall (thankfully). Woodside Fire Administration continues to be closed to the public. We are reevaluating periodically. We are still good on PPE for our first responders.

First responders, countywide, completed their second vaccination last week. The San Mateo County Fire Service is now assisting San Mateo County Health with mass vaccinations. Around 20 personnel have been assigned to help vaccinate citizens this week. Every agency has committed 2-3 personnel that are qualified to vaccinate. We anticipate this may continue to happen as more vaccine become available to vaccinate more people.

Recent Storms/Atmospheric River: Fortunately, the Fire District did not take a direct hit from the storms. Call volume was light. Reports from both Towns were similar. There was minimal damage, and public works call volume was light.

A task force of fire equipment was sent to Santa Cruz to preposition in case there was a need to assist with post-fire debris flow issues. They remained down there for a couple of days and, fortunately, were not needed for any emergency issues.

Below are three conclusions/recommendations to the EPC from a joint meeting of the subcommittee on CERT/Woodside/PV integration and the Medical subcommittee

The membership of both committees, Craig, Ray, Jerry, Chris, met on Friday 2/19

- Merge the two subcommittees (Integration and Medical) into one.
 - WPV-Cert has trained members who can supply basic first aid and have been trained to do so per WFPD rules and WPV-Cert Standard Operating Procedure (SOP)
 - WPV-Cert has basic supplies for its trained members and will have some inventory at the Town Incident Command Post (ICP)
 - Medical supplies and response have been topics which have historically, for a variety of good reasons, not gained traction with the Town and the EPC
- Set a goal of always having a physician (MD) on the Town EPC
 - A Physician (MD) on the EPC is critical to maintaining communication and relationships the Medical Reserve Corps of SM County
 - o A Physicien (MD) can advise the EPC and Town on issues such as PPE requirements
 - We feel that if these first to actions are taken, this is a more efficient use of resources than having a separate Medical Subcommittee
- Form a new subcommittee of the EPC: WPV-Ready Liaison
 - Among the most important tasks for emergency preparedness is the promotion of household preparedness - a joint goal of the EPC and the WPV-Ready
 - WPV-Ready integration into the Town plan bolsters the reach of both organizations with a common message and should have a focal point, leadership from the EPC
 - There are likely synergies with the Outreach subcommittee of the EPC, the Town public relations function, and possibly Neighborhood Watch
 - While both WPV-Cert and WPV-Ready are connected at the CERPP level, the subcommittee thought that the size of the two functions was large enough to merit separate subcommittees with separate, focused leadership

One additional update for the meeting:

- We have consensus for a location for the WPV-CERT trailer for Portola Valley.
 - It will be next to the Annex building on either the road side or opposite, in a parking spot.
 - Jeremy and Howard from Town and Chris, Mark, Selena from WPV-Cert are all on board

Medical Subcommittee Report PV EPC March 4th

I met with Chris Raines and Craig Taylor to discuss the possibility of merging the medical subcommittee and the CERT Integration Committee. It was a very productive meeting and the findings will be presented by Chris.

I have been meeting the WPV-Ready and WPV-Cert members to determine what medical equipment should be available for the trailers. A second trailer has been ordered by Mark Dahlen and might be here within the next 2-4 months. Chris mentioned earlier to the committee that he has agreement from the town of PV to store the trailer next to the Sheriff station.

We are currently working on a plan that would include 10 medical packs that could be used by CERT teams sent to the field as well as a plan for stocking the trailer for a medical station that would be deployed for indicated events. The exact inventory is under discussion.

RE: Donation Program for Small-Scale Town Projects (formerly PV Donates)

RECOMMENDATION

Staff recommends that the Town Council consider the implementation of a donation program to fund small-scale Town projects.

BACKGROUND

The Town's incorporation was made possible by the countless hours and resources volunteers made to implementing a vision of a community where public service and financial support was central. Residents have donated millions of dollars to fund community-benefitting projects, such as the acquisition of open space, reconstruction of Town Center, and other town-defining endeavors.

Providing different ways for residents to participate in the public process is key to the continued success of the Town, and the projects the Town Council, the committees, and residents alike support.

DISCUSSION

The Town does not currently have a program that allows residents to fund/support small-scale projects. While staff, for the purposes of this staff report, did not attempt to define what a "small-scale project" is, staff did create a list of potential projects that such a program could support (Attachment 1).

A program like this exists in many other cities today, typically in the form of a Parks and Recreation program that funds benches, tree plantings, and other such small projects. Donated funds are typically tax deductible, and are supported by some type of acknowledgement that requires further discussion.¹

Staff believes that many residents would support discreet programs in their areas of interest (trails, fields, sustainability demonstration projects, bicycles, and children/youth) through modest donations.

¹ While programs in other cities support branding opportunities (naming facilities and events, for example), the staff strongly recommends that no such opportunities be included as part of any future program.

Such projects should be initially developed by the Town's committees, and could be supported by Council and staff recommendations. The appropriate committee would review resident recommendations.

Staff requests that the Town Council provide feedback on this nascent idea, with additional review by committees as part of the next round of development. Questions for the Council include:

- Should there be a range of funds that could be donated?
- Does the Council wish to discuss recognition of donations at this meeting or a future meeting?
- Are there types of projects that you would want included in this program? Any that should not be included?
- Should such a program be bound by an annual work plan, or be on an ad-hoc basis, as ideas come up?
- Should there be a match to the program from Town funds?

FISCAL IMPACT

There is no fiscal impact in receiving this staff report and providing guidance. Should such a program be created, there will be modest support from staff/contractors to ensure that any adopted program is implemented and projects are completed.
