4 WPV-CERT/WFPD Report

- Chief Linder reported that the CZU fire still has a few hot spots, typically underground roots that continue to burn. CalFire is using planes with infrared detectors to find the remaining hot spots
- As a result of CZU and Kincade fires, CalFire is planning aggressive evacuations with 72 hour preplanning and large area evacuations well in advance.
- Reminded everyone that evacuation routes will vary based on the location of the fire.

Dale- since I will not be able to attend the EPC meeting next Thursday morning, I wanted to request that the following message be distributed as oral communication. I have spoken with Craig about this, and he is familiar with the issues I am raising.

As you are probably aware, with the upcoming fire season, there has been a strong and growing concern expressed about the lack of a meaningful evacuation plan in Portola Valley. This has been particularly true of our neighborhood preparedness committee on Golden Hills, and I know of similar sentiments by other neighborhood groups.

I am also aware there are several well-intentioned efforts being considered or underway to develop a comprehensive evacuation plan. However, in the interim, neither I nor my neighbors are aware of any plans which have been put in place pending the more comprehensive plan. As you can understand, given that it is likely there will be literally thousands of cars seeking egress in a fire emergency threatening Portola Valley, this subject is of immediate concern. For example, what plans exist to provide traffic control, and what resources would be trained and available? This is a particular concern in light of the limited fire and police personnel available to cover a large, county geographical area.

I raise this not as a criticism of our very capable fire and police professionals, but rather in recognition that we need some <u>interim</u>, available plan pending a more comprehensive evacuation program, which may be underway.

I understand from my conversations with the WFD that past attempts to arrange for a practice evacuation have been unsuccessful for lack of community support. I believe the greater current recognition of our high vulnerability to fires has dramatically changed our community attitude, and made our residents more receptive to such an important exercise.

If appropriate, could the EPC address this issue, or suggest how we might otherwise move forward to create an interim evacuation plan for this coming fire season. Please feel free to call me to discuss this further. Thanks for your attention to this request, and for all the good work done by you and the EPC.

WPV-Ready/WPV-CERT Monthly Update April 2021

The quarterly meeting for The Citizens for Emergency Response and Preparedness Program, Inc. was held. The next meeting is scheduled for July 21st at 5:30pm.

- There was discussion about removing C.E.R.P.P. from visibility due to the confusion it causes between WPV-CERT & WPV-Ready. We want to community to think of the two primary programs, and not the parent corporation.

WPV-Ready

- May is Wildfire Awareness month and WPV-Ready is planning a campaign in conjunction with both Towns and the Fire District. It will be based on the Ready, Set, Go! program. The WPV-Ready website will offer information specific to our Fire District with the ability to access the full program via www.readyfirwildfire.org.
- A wildfire preparedness presentation is scheduled for May 22nd, 4-5pm.
- We continue to receive data forms from residents. We have received close to 400 forms so far.
- Have received ArcGIS data and are now working on maps
- There was a WPV-Ready Leadership meeting on April 1st. A follow-up meeting has been scheduled for May 7th 4-6pm, to further discuss SMC Alert, wildfire & evacuations topics.
- The WPV-Ready Organizing Principles document has been approved by the Board as well as the Division Leaders. The next step is to work on a charter.

Woodside Fire Report June 3rd, 2021

<u>Vegetation Fires in the District:</u> There have been 3 vegetation fires in the District over the last month, 2 in the Portola Valley area (South of Alpine Road bordering the County line) and 1 in the Huddart Park/GGNRA area. All fires were kept small. Multiple jurisdictions assisted with these incidents.

<u>Sequoia's Evacuation Drill:</u> WFPD, San Mateo County Sheriff's Office and San Mateo County Health/EMS assisted Sequoia's staff and the Town with an evacuation of the independent living portion of the facility.

Station 7 Build/Station 8 Remodel: Progress continues on the progression through both Town's Planning Commissions. The Station 8 remodel will be going back to the Planning commission, then to the Town Council. A location for the temporary Station 7 is getting closer to having a signed contract.

Evacuations/Traffic Study/Wildfire Cameras: Discussions continue with representatives of the Town of PV, Town of Woodside, County of San Mateo OES, and San Mateo County Sheriff's Office regarding emergency notifications, evacuations, and potential traffic issues. Outreach to the community is planned in the near future.

WPV-Ready

- The Wildfire Awareness Month messaging has been going great. Check out the www.WPV-Ready.org/wildfire to view the content.
- Our Wildfire webinar on May 22nd had 68 attendees.
- WPV-Ready is using Emergency Communications Day (Field Day) has a goal to have the 1-page topics sheets (based on evacuations, staying informed, food & water) ready.
