SPECIAL TRAILS AND PATHS COMMITTEE MINUTES – Tuesday, August 17, 2021, 8.15 am

**CALL TO ORDER:** The meeting was called to order at 8.11 am.

**ROLL CALL**: J. Coleman, B. Eckstein, E. Ferrari, S. Gold, G. Hanning, M. Nicholls. C. Hughes, Town Council Liaison; H. Young, Public Works Director; Guests: Kristi Corley, T. Coleman, Conservation Committee; Mary Hufty, Westridge Committee.

**ORAL/COMMUNITY COMMUNICATIONS**: None.

**APPROVAL OF MINUTES**: G. Hanning made a motion to approve the minutes of Tuesday, July 20, 2021, E. Ferrari seconded, all were in favor, except F. Leach who was absent.

#### **OLD BUSINESS:**

- a. Trail Conditions and Work for July, 2021: Howard Update/Discussion: Trail work has been done. H. Young will follow up with E. Ferrari re. 170 Cherokee Way and town trail. T. Coleman asked how to have town remove Stinkwort, (Dittrichia), and was advised to use PV Connect. It needs to be removed before going to seed. The annual re-surfacing projects will begin next week. The slurry seal will occur on 25 streets and is posted on the website. Crosswalks will be re-sealed. S. Gold noticed that not all crosswalks are upgraded to similar striping. H. Young said each crossing is different. They are listed on the website. There are 9 locations for crosswalks. Golden Oak/Alpine Hills and in front of Priory are slated for lighted crosswalks. Will be up for public comment before building. 160 Fawn: Gary says can take poles off trail as construction has ceased. Can we have them restore trail and cut hedge back a foot or two? Howard says the final is not through yet and asks for photos of what needs to be done. Howard and Gary will talk offline. Per Barb Eckstein, the hedge has grown into the easement and there is not enough room to use trail between hedge and mailbox. Escobar trail: Sign saying 'No horses, Hikers ok'. Mary Hufty preparing a legal document for Westridge trails. S. Gold asked about Alamo trail. It has been restored, per Mary. Gary and Howard will check whether new homeowners are informed when there is a trail on their property.
- b. Stanford Faculty Housing Subcommittee: Group Update: All committees invited to review site. Some members have already signed up and Gary encourages everyone to do so. Can see where proposed housing and trails will go. Kristi Corley said Open Space Committee wants to know where easements are as they may allocate funds for purchasing. SB9 EPA protections are taken away and no public comment is allowed, such as with ADU's. Only very high fire areas, such as Wayside and Woodside Highlands, will be exempt. Other areas in town are not high fire. SB10 will permit houses on any lot. If either one passes, our town will change. Gary says when developers make plans, they need to show easements on plans. ADU's don't show trails. If they do build on an easement, we can ask them to move it. Gary met with residents re. Wedge trails, where

- houses are going to go and also where trails go. Want to incorporate Canyon trail. Won't become a town trail as residents do not want to give up or sell easements. Very good chance that it could become a formalized Westridge trail. They are concerned about the project, the closer they are to the project. Homeowner of ADU on Cervantes may be willing to let trail be used behind ADU, as part of Westridge Canyon trail.
- c. Ordered List of Trail Mowing: Joe Coleman Update: No news as Joe has not had a chance to do anything. Will meet with Howard when he is able to work on it. May 15-July 30th is when mowing happens. Have to balance fire mitigation and expectations of users.
- d. Trails and Paths ADU Checklist Items: Group Update: Will not be reviewing plans for ADU stand-alone projects. Gary worked with Laura Russell and Craig Hughes and submitted a check list from PVTC. He will send list of items to committee members. Need to get ADU's as far away from trails as possible. Kristi Corley asked if it is possible for the Town Council to get PVTC involved and have someone come out to check on the ADU. The town can write in what it wants. Gary says we won't be going out to sites as we won't know. Could we have town write in a resolution? Only 30 days' approval time. Can't slow project down. Building Dept. is open to this, per Gary. C. Hughes says if they build on a trail easement, we can make them move the ADU. Other hazards are sprinklers. Kristi asked if Woodside has different ADU laws and why can't we do the same?

#### **NEW BUSINESS:**

a. PARKS AND RECREATION DOG PARK PROPOSAL: Discussion: Making a proposal to build a dog park at the Town Center. They are preparing a presentation and we will invite them to come before our committee. We will lose our Horse Fair area and there is a big concern about dogs charging the fence and frightening horses onto Portola Road, as the town trail is nearby. They said they could move park in a bit to accommodate this. Howard says it is at the stage of reaching out to other committees before moving forward. We need to share alternate locations with them, per B. Eckstein.

#### OTHER BUSINESS:

a. An application to join the committee has come in from Jacqueline Davis. Not available today. Liz Babb, who lives in Woodside Highlands, is also interested in joining.

**ADJOURNMENT:** E. Ferrari made a motion to adjourn, S. Gold seconded, all were in favor. The meeting was adjourned at 9.10 am.

The total maintenance staff hours worked in August was 35 hours.


