Remote Meeting Covid-19 Advisory: On September 16, the Governor signed AB 361, amending the Ralph M. Brown Act (Brown Act) to allow legislative bodies to continue to meet virtually during the present public health emergency. AB 361 is an urgency bill which goes into effect on October 1, 2021. The bill extends the teleconference procedures authorized in Executive Order N-29-20, which expired on September 30, 2021, during the current COVID-19 pandemic and allows future teleconference procedures under limited circumstances defined in the bill. Portola Valley Town Council and commission and committee public meetings are being conducted electronically to prevent imminent risks to the health or safety of attendees. The meeting is not available for in-person attendance. Members of the public may attend the meeting by video or phone linked in this agenda.

# 5. WPV-CERT/WFPD Report (Brown/Lindner)

- WFPD is not yet requiring mandatory COVID vaccinations, but vaccination rate is over 90%

- Completing Fire Captain exams; could be 4 or 5 promotions
- Statewide, there are still 10 major fires burning; 8 are 75% contained

- CERT Tabletop Command Post training will take place on October 30
- Selena is working with YMSL and will start brush clearing on eligible properties with 20-25 young men

#### **Radio Communications Status**

# All repeaters remained online during the several recent power outages.

- 1. Repeaters and AM: as of this report all radios/repeaters fully functional
  - a. AM Radio (WRML513). Operational at 100% power.
  - b. PVARC (KM6DLG) amateur repeaters fully operational.
    - i. New 6m (VHF-lo) amateur repeater on PVARC now operational.
  - c. NVN Repeater (WB5NVN) amateur repeater fully operational.
  - d. San Mateo Sheriff's Net (f.k.a. OES) (KC6ULT) UHF link fully operational.
  - e. WPV-CERT Portola Valley GMRS (WQBS772) repeaters (PV1, PV2, PVT) fully operational.
  - f. WPV-CERT Portola Valley digital repeater fully operational.
- 2. AM Antenna Relocation Project to Cal Water site at Peak and Golden Oak
  - a. H. Young working the matter. No update.
- 3. <u>WPV-CERT Repeater Network</u>
  - a. Easter Cross Repeater Project.
    - Needing WPV-CERT to sign the agreement with RWC, required for final permit to construct. Contractor is available mid-Nov. Will take 5 days to complete infrastructure.
  - Assisting LTW/VV with repeater locations, antennas, power, and such.
     Reconfiguring LTW/VV repeater infrastructure. Power outage revealed a lot of holes in power.

- 1. Really need to audit and check communications equipment in town. For example, phones were out because of no electricity. Radios there are battery backed up.
- 2. Battery refresh likely on DC power supply in Town radio room.
