2021 Indicators Report Focuses on Solutions to Housing Crisis

Housing experts at the recent online launch of Sustainable San Mateo County's 25th annual <u>Indicators</u> Report said political leadership, funding and aggressive use of land are needed to solve the county's ongoing housing shortage.

The Indicators Report Launch on Zoom featured three experts who are working on creating affordable and equitable housing for everyone: Rick Bonilla, Deputy Mayor, San Mateo; Diana Reddy, Council Member, Redwood City; and Matt Franklin, Chief Executive, MidPen Housing.

The full Indicators Report, as well as an executive summary, a brochure and a video of the Indicators Report Launch event, can be accessed at tinyurl.com/2021SSMCIR.

Among the key findings of the report are:

- Between 2010 and 2019, nearly 11 times more jobs were created than housing units.
 Sustainable San Mateo County determined that 330 developments currently under consideration in the county would create more than four times more jobs than housing units in the pipeline.
- In order to afford an average two-bedroom housing unit in San Mateo County, renters need to earn about \$51 per hour, more than three times the county's minimum wage, which is \$15.62 per hour.
- A large segment of the population cannot qualify for affordable housing because they don't earn enough money. There are very few spots available for people earning 30 percent of the Area Median Income (below \$38,400 for a household of one, below \$54,800 for a household of four), who are designated as extremely low income.
- Many extremely low-income people in the county are one medical crisis or paycheck away from homelessness. It's important to help them stay housed. If just 6 percent of the extremely low-income individuals in the county lose their homes, the county's homeless population (1,500 in 2019) will nearly double.

Among the positive forces the report found that are beginning to address the housing problem are the California Comeback Plan, which is the largest investment in housing in state history; the state's Homekey Program, which transitions hotels into housing for homeless individuals; funds that San Mateo County is devoting to housing from Measure K, the half-cent sales tax that supports essential county services; and new state legislation that makes it possible for homeowners to add more units on single-family lots.

The report includes 30 proven solutions for expanding affordable and equitable housing, including insisting that affordable housing is part of every new commercial project; trading public land, such as city parking lots, for affordable housing; working with corporations, school districts and others to create

housing for local employees, teachers and disabled individuals; trading housing credits with other cities; and protecting renters with "option to buy" arrangements, speedy legal help when they face eviction and relocation benefits.

Each year, Sustainable San Mateo County's Indicators Report does in-depth research on one aspect of sustainability performance in the county. This year's report on Equitable Housing includes comprehensive data, the historical context, driving forces, an analysis of the impact of climate change on housing, case studies and recommended solutions and policy initiatives for San Mateo County.

One key finding in the report is that between 2019 and 2019, nearly 11 times more jobs were created than housing units. Sustainable San Mateo County determined that 330 developments currently under consideration in the county would create more than four times more jobs than housing units in the pipeline.

The report also found that renters need to earn 3.2 times the minimum wage to afford an average two-bedroom housing unit in the county, and that many extremely low-income people in the county are one medical crisis or paycheck away from homelessness. If just 6 percent of extremely low-income individuals lose their homes, the county's homeless population will double.

The report offers examples of new policies and on-the-ground solutions that are beginning to make an impact on the problem.
