Remote Meeting Covid-19 Advisory: On September 16, the Governor signed AB 361, amending the Ralph M. Brown Act (Brown Act) to allow legislative bodies to continue to meet virtually during the present public health emergency. AB 361 is an urgency bill which goes into effect on October 1, 2021. The bill extends the teleconference procedures authorized in Executive Order N-29-20, which expired on September 30, 2021, during the current COVID-19 pandemic and allows future teleconference procedures under limited circumstances defined in the bill. Portola Valley Town Council and commission and committee public meetings are being conducted electronically to prevent imminent risks to the health or safety of attendees. The meeting is not available for in-person attendance. Members of the public may attend the meeting by video or phone linked in this agenda.

### **CONSERVATION COMMITTEE MEETING MINUTES - DRAFT**

Call to Order: The meeting was called to order at 7:01 PM

#### Roll Call:

#### 1. Oral Communications: none

**2. Approval of Minutes for September 2021:** The minutes were *unanimously approved as written.* 

### 3. Old business

- a. Redwood guidelines (Murphy)
- i. Revision to guidelines (previously approved September 28, 2021) incorporating more precise language regarding appropriate microclimates was *unanimously approved as written*.
- ii. Permit fee waiver for removal of stressed redwoods

A clear, workable definition of what constitutes stressed redwoods is needed, possibly including photographic examples. The subcommittee (M. Plunder [head], Heiple, Magill, and Walz) will develop. N. Chiariello agreed to join the subcommittee (Heiple will transition off after the first meeting).

### iii. Redwood microclimate map

Both Heiple and Walz have potential maps but have not yet coordinated (to be done ASAP). The map is intended to show where in Town redwoods are likely to do well.

### b. Ad Hoc housing

The Committee identified the following as issues/concerns to be addressed:

Preservation of wildlife corridors

- Fencing, including the use of hedges as screening (needs to be addressed thoughtfully and carefully)
- Heritage trees protection
- Maintaining/respecting scenic corridors, including mandatory setbacks
- Emphasis on native landscaping and low water use plants

The Committee agreed a cluster housing approach could be appropriate, possibly including underground parking, with emphasis on careful water usage, appropriate landscaping and consideration of potential impact on emergency evacuation activities.
