Subject: RE: Request town government reconsiders its decision to not organize evacuation drills

As long as I'm being mis-quoted, "for the record" here is what I said, and Angela faithfully recounted:

The town would "overall be in good shape" during an evacuation, Cardinal said, based on his models. It would take between two to four hours after an evacuation order is given, according to his simulation. Major factors include:

- How many people would have already left, assuming there was a prior warning
- How many cars each family takes
- How long it takes people to pack up and start out
- What complications occur (downed lines, accidents, roads closed, etc.)

If more residents move into town, for evacuation purposes, it'd be best for them to live near exits in town. Stanford University's proposed Wedge project is located just south of Interstate 280 on Alpine Road. There could be up to 7,500 cars that leave Portola Valley during an evacuation, but realistically residents are not all going to leave at the same time, he said.

His simulation shows police intervention will be "really important."

"Some intersections are particularly tricky," he said. "The (town) traffic plan has traffic control points and expect they can do that (in an evacuation)."

Cardinal said the biggest surprise from the model is that if you make Arastradero Road one way for outbound traffic, on paper it serves as a decent third alternative route.

"I'm hoping this is a place where the traffic engineers can help us decide if that's realistic," he said.

There's no way to exit to a main roadway from the town to the west and that can't be fixed, he noted. If there's a fire along the 280 corridor, then residents might have to shelter somewhere like Corte Madera School, near the Frog Pond.

He also noted it would be ideal if there was another way to get out of the Ladera neighborhood.

He said Portola Valley residents are rightly worried about fire risk and losing their home insurance policies, a trend in recent years.

"Some level of fear makes sense," he said. "I do think a lot of people are very sincere. I think some other people just want to leave things the way they are. The world moves. Stanford owns 75 acres and it's their land. It's America, you get to do stuff with your property."

While I support the petition currently being circulated concerning fire safety in Portola Valley, I would like to identify the following issues as particularly important to me. I live in Portola Valley Ranch, where the Town required that houses be tightly clustered in order to preserve open space. I am therefore especially concerned about issues raised in this petition and its background materials

- 1. The Town has made considerable progress by reducing the amount of fuel along Alpine and Portola Roads and encouraging residents to do the same on their roadside properties, for which thank you. This is an important step toward safer evacuation routes.
- 2. I believe it is important to encourage all residents to take greater measures to reduce fuel along streets, particularly low-hanging branches and shrubs that might reduce visibility or enhance flame spread during a wildfire evacuation, and particularly on any street that is a major corridor out of a specific neighborhood.
- 3. On the issue of building separation, the danger of proximity is due primarily to radiant heat from one structure to another. It's simple physics: if one house catches fire, it will ignite any other structure that is too near it or linked to it by foliage. I feel strongly that the NFPA standard of 30-foot separation between structures is essential. This should not diminish our ability (or our willingness) to provide below-market housing. Rather, it should ensure that housing be provided safely for new as well as current residents.
- 4. For new developments that seek clustered housing, attached structures such as town houses should be considered as a means of avoiding structure-to-structure fire danger.
- 5. On narrow streets, adequate parking should be required for any new construction to ensure ingress for emergency vehicles if resident vehicles are evacuating. Consideration should also be given to restricting parking on the street in such areas.
- 6. Any variance issued to permit separation of less than 30 feet between two structures or a structure and the road or property line should include the requirement that new construction be of noncombustible materials. Consideration of any request for such a variance should also take into consideration the state of the older building and its vulnerability. One neighbor's building should not threaten another's survivability.

Thank you for the time that all of you are putting into sorting through these complex issues and working to resolve conflicts that Portola Valley faces in a challenging situation. I have been deeply impressed by the thoughtfulness of members of the Wildfire Preparedness Committee and the Town Manager in addressing these issues, and I appreciate as well the extra ordinary number of hours required of Council members as you face these very complex and important issues.

Hi Jeremy,

Thank you for your reply.

For the record, I would like to add the following comments:

(1) Re. our conversation about neighborhood drills:

Correct, you did mention that neighborhood drills took place for the Sequoias and the Ranch and offered my neighborhood could request one. That was not my ask and that of many PV residents. As stated in my email, I contacted you about a town-wide evacuation exercise. Given that we only have three evacuation roads that are shared among all neighborhoods, isolated neighborhood exercises are useful but don't paint the full picture. As we've discussed in the past, there are many reasons why cities do not conduct city-wide drills. They include that you cannot get every person to participate, not everyone leaves at the same time, and one would effectively be shutting down the city for some period of time.

(2) Re. on what Mill Valley is doing:

I am confused. Mill Valley DID do an evacuation drill. Moreover, it is an annual event. Even better, they work with Google researchers to use the collected data to get to a better simulation model. Please do look closer at their entire program: evacuation drills in combination with simulation. I have spoken directly with Mill Valley representatives. Their <u>drills</u> are not city wide; the last drill was to a selected group to validate their study. Here is a link to a story about the drill. As you can say, while it's called "city wide", 200- 300 people participated. The population of Mill Valley is 14,330. The drill involved lining up 250 cars on East Blithedale (one of at least three evacuation routes out of Town) to validate their Google data.

The Town did not reach this decision on its own. It was made in consultation with the Woodside Fire Protection District, the Sheriff's Office, and the County Department of Emergency Management.

(3) Re. environmental impact report for the Stanford Wedge: Yes, I am aware of this and look forward to the report.

- (4) I would also like on the record my concern about the lack of transparency of the simulation work Mr. Cardinal is doing, especially since Mr. Cardinal will be working with the consultants the town has hired to develop simulation models.
- Mr. Cardinal was ready to state his conclusion in that the town (Portola Valley) will be fine during an evacuation, but he is still not ready to share his methodology. If the town does use Mr. Cardinal's work, the residents (and not only the Almanac) are entitled to know how Mr. Cardinal came to that conclusion. If Mr. Cardinal does not share it, I expect the town will.

I believe our town has plenty qualified engineers and scientists to review Mr. Cardinal's work. **David is a private citizen who took on this work on his own accord. I've asked the consultants to take a look at it.**

I appreciate my emails are added to the Public Digest.

Sofie – acknowledging receipt from my end of your email. Thanks for including me. (I've blind copied the Council to avoid any Brown Act violations)

I thought I'd add a slight correction to your email. When we spoke earlier this year, I mentioned that the Town (along with who would body that would have primary responsibility for organizing the drill, the Woodside Fire Protection District) would be happy to hold neighborhood drills with any area of town that wishes to do so. There was also a joint message on this general issue.

A good example of our approach is what Mill Valley is doing. They've done some exceptional evacuation work, similar to our ongoing study, that they are now <u>using</u> for validation purposes. They do not plan, at this time, to hold a town-wide drill, for the same reasons I mentioned to you when we chatted.

I'll also note (I believe that we chatted briefly about this as well) that the Stanford Wedge project will have an environmental impact report that will look at potential impacts of the development on safety issues, including evacuations.

I hope you and yours are well.

Dear Town Council, Members of the Wildfire Preparation Committee, Members of the Emergency Preparation Committee, Town Manager Dennis

I am writing you to address a major concern that I feel is not addressed adequately, namely evacuation. Earlier this year, I approached Jeremy Dennis with the question of whether a town evacuation could be organized for all PV residents. Jeremy told me then that he does not believe in such exercises (to name a few reasons: they typically yield low participation; they can never emulate a real scenario). You may be aware that I then organized a grassroot evacuation exercise. In doing so, I received numerous comments from residents stating they wished this exercise would be a townled or at a minimum town-endorsed activity. I humbly request that our town government reconsiders its decision to not organize evacuation drills.

I understand our town is in contract with an organization that is creating evacuation simulation models. I look forward to these results, expecting they will be shared in detail with the community. I believe taking one such scenario and executing on it would be a good way to validate the simulation model.

Whatever form an evacuation drill takes, I can add with great confidence that this exercise would build the community we so need now.

You may be aware that a petition is coming your way signed by residents requesting that the Town takes specific action at the Town Council meeting on December 8 to protect the Town from wildfire risk. The petition is indicative of a widespread desire to be prepared in every way possible.

It is imperative we fully understand our evacuation capacity (and adjust accordingly) in the discussion of the development of the Stanford Wedge and the implementation of SB 9.

I hope you will seriously reconsider organizing an evacuation exercise or at least endorse it. I will gladly help with the organization effort.

The Bicycle and Pedestrian Advisory Committee (BPAC) provides advice and recommendations to the full C/CAG Board of Directors on matters relating to bicycle and pedestrian improvement projects. The BPAC advises the C/CAG Board on priority projects for funding through the Transportation Development Act Article 3 grant program and the One Bay Area Grant program. In the upcoming year alone, the Committee will participate in the selection of up to \$30 Million of active transportation projects in the County.

Meetings are held bi-monthly on the fourth Thursday of the month at 7:00 p.m. Prior to the COVID-19 Crisis, the meetings were held in the San Mateo City Hall. During the COVID-19 Crisis, the meetings have been held over Zoom. The BPAC has approximately six meetings per year. No more than two BPAC members can reside in the same jurisdiction. There are three vacancies for elected officials on this committee. For more information about the Committee and Meeting agendas, contact Kaki Cheung at kcheung1@smcgov.org; and/or see <a href="https://ccag.ca.gov/committees/bicycle-and-pedestrian-advisory-committee/.

The Congestion Management and Environmental Quality Committee (CMEQ) provides advice and recommendations to the full C/CAG Board on all matters relating to transportation planning, congestion management, travel demand management, coordination of land use and transportation planning, mobile source air quality programs, energy resources and conservation, and other environmental issues facing the local jurisdictions in San Mateo County. The role of the CMEQ Committee also includes making recommendations to the C/CAG Board on the allocation of funding for specific projects and activities addressing these programmatic areas. The Committee meets on the last Monday of each month from 3:00 p.m. to 5:00 p.m. Prior to the COVID-19 Crisis, the meetings were held in the San Mateo City Hall. During the COVID-19 Crisis, the meetings have been held over Zoom. There is a vacancy on this committee for an individual representing agencies with transportation interests. The Resource Management and Climate Protection Committee (RMCP) seats seven elected officials and public representative seats for each of the following six specialties: energy, water, utility, nonprofit, business/chamber of commerce, and environmental organization, for a total of 13 seats. Originally called the Utilities Sustainability Task Force (USTF), it developed a San Mateo County Energy Strategy for the county, which was adopted by every city in San Mateo County in 2009. The RMCP Committee provides information and recommendations to CMEQ and the C/CAG Board on items related to resource conservation and climate action. The Committee also tracks the progress of two main C/CAG programs, the San Mateo County Energy Watch (SMCEW) and the Regionally Integrated Climate Action Planning Suite (RICAPS). The Committee also seeks to integrate equity into resource conservation and climate actions, including workforce development, access by constituents, and inclusion of input by community-based organizations. Most recently, in coordination with BAWSCA, the Committee is exploring actions to reduce demand on potable water supplies, such as One Water programs, and electrification and resilience of homes and communities through nano- or micro-grids, respectively. The RMCP Committee meets on the third Wednesday of the month (as needed) throughout the year at 3:00 p.m., in either San Mateo at 155 Bovet Rd., or Redwood City at County Center, or virtually by Zoom meetings due to COVID-19.
