Subject: Volunteer Code of Conduct

In the recent years, our town has lost several volunteers because of extremely challenging situations within the committee settings. We have a Commission and Advisory Committee Policies and Procedures last updated in 2015. The current procedure only specifies the following:

"Removal — If the Mayor, the council liaison and commission/committee chair all concur that a member is not fulfilling the duties (i.e. repeated failure to attend meetings, violation of ethical standards, disruptive behavior, repeated failure to abide by Commission/Committee handbook rules, etc.) of the committee, the Mayor may revoke the appointment of a commission/committee member."

No where in this document is any requirements for a code of conduct or anti-discrimination or harassment policy.

In both my professional and volunteer positions in life, I have been required to up front agree to a set of professional and ethical conduct before working or volunteering. In organizations both large and very small, a system exists to allow an individual to contact a neutral professionally trained party to discuss the situation and correct it when deemed a valid concern. Often this process can result in a corrective action that restores harmony to the organization and does not require the removal or resignation of any volunteers.

In Portola Valley, the volunteer must convince three people: the Mayor, the council liaison, and commission/committee chair of their case in order to remove that individual. No process exists to warn or reprimand the individual prior to removal. The requirement to convince three non-trained community members with potentially existing ties to the troublemaker is an onerous task for the whistleblower.

I urge the Town Council to develop a modern Code of Conduct for volunteers (committee and commission members, and the town council) supported by a reporting mechanism, an investigative procedure, and corrective actions.

Many policies are available on the web to use as a model. I found a "Code of Conduct - Volunteers" from Codepath which can serve as a starting point for discussion.

Here are some key highlights:

It is your responsibility to understand and comply with the specific policies of this Code of Conduct. Any violation of this Code may result in disciplinary action, including the cessation of your volunteer position at CodePath and removal from the CodePath community.

If what you're doing is making someone feel uncomfortable, that counts as harassment and is enough reason to stop doing it.

Our policy is to take prompt action to enforce this Code of Conduct and all of our other policies. Depending on the seriousness of the violation and the other relevant circumstances, violations of this Code may result in a formal or informal warning or reprimand, suspension, cessation of volunteer services, or other disciplinary action, including removal from the CodePath community.

If you become aware of any violation or suspected violation of this Code, or are asked to depart from this Code of Conduct, please report it immediately to report@codepath.org. All complaints will be investigated and prompt corrective action will be taken, as appropriate. Interim measures may be taken, as appropriate, when a complaint is made. We will not discipline, discriminate against or retaliate against, or tolerate any discrimination or retaliation by any other person against, any person who in good faith reports a violation or suspected violation of this Code.

Re: April 21, 2020 Decision of California's Fish & Game Commission

Dear Mayor Hughes and Chairperson Taylor,

On April 21, 2020 the California Fish and Game Commission designated the Central and Southern Coast Evolutionary Significant Unit (ESU) of mountain lion as a Candidate Species under the California Endangered Species Act. A copy of the Commission's April 21, 2020 written findings for its decision is attached.

I respectfully request the Town of Portola Valley to review and enforce the Commission's April 21, 2020 decision by suspending all action on any lot split or subdivision application under SB-9 pending final decision of the Commission to deny protection to the designated sub-species of mountain lion. I also request that the Town include a copy of this letter in the Town Digest and public Agenda packet for the next Town Council meeting.

Pursuant to Fish and Game Code section 2068, a

"Candidate species' means a native species or subspecies of a bird, mammal, fish, amphibian, reptile, or plant that the commission has formally noticed as being under review by the department for addition to either the list of endangered species or the list of threatened species, or a species for which the commission has published a notice of proposed regulation to add the species to either list."

The State's designation of the Central and Southern Coast ESU of mountain lion as a Candidate Species includes the sub-species of mountain lion occupying the CC-N (Central Coast North) habitat and thus all of Portola Valley.

Until the Fish and Game Commission makes a final decision to deny protection, the decision to grant the CC-N mountain lion Candidate Species status within the designated habitat area precludes application of SB-9 within that area. Pursuant to Government Code section 66411.7(a)(3)(C), a local agency may ministerially consider and approve a parcel map for an urban lot split pursuant to SB-9 "only if the local agency determines that the parcel map for the urban lot split ... satisfies the requirements specified in subparagraphs (B) to (K), inclusive, of paragraph 6 of subdivision (a) of Section 65913.4." Section 65913.4(a)(6)(J) of the Government Code precludes application of SB-9 to lot splits or subdivisions located on a site that is

"habitat for protected species identified as candidate, sensitive, or species of special status by state or federal agencies, fully protected species, or species protected by the federal Endangered Species Act of 1973 (16 U.S.C. Sec. 1531 et seq.), the California Endangered Species Act (Chapter 1.5 (commencing with Section 2050) of Division 3 of the Fish and Game Code), or the Native Plant Protection Act (Chapter 10 (commencing with Section 1900) of Division 2 of the Fish and Game Code)."

Section 17.13.020(m) of the Town's recent SB-9 emergency ordinance specifically adopts and incorporates this mandatory exemption from SB-9 for all lands within protected habitat as an express exemption from SB-9 within our Municipal Code:

"The parcel does not contain habitat for protected species identified as candidate, sensitive, or species of special status by state or federal agencies, fully protected species, or species protected by the federal Endangered Species Act of 1973 (16 U.S.C. Sec. 1531 et seq.), the California Endangered Species Act (Chapter 1.5 (commencing with Section 2050) of Division 3 of the Fish and Game Code), or the Native Plant Protection Act (Chapter 10 (commencing with Section 1900) of Division 2 of the Fish and Game Code)."

Consequently, our Municipal Code also requires the Town to refrain from any consideration of SB-9 applications until the Commission renders a final decision.

Because the State's designation of mountain lion within the Central and Southern Coast Evolutionary Significant Unit includes all of Portola Valley, the requirement to protect and maintain mountain lion habitat throughout Portola Valley is also directly relevant to the Town's pending update and amendment of its Housing Element. Please ensure that the Ad Hoc Housing Element Committee is advised of the law's requirement to protect mountain lion habitat throughout Portola Valley.

CALIFORNIA FISH AND GAME COMMISSION NOTICE OF FINDINGS

Mountain Lion (*Puma concolor*)

NOTICE IS HEREBY GIVEN that, pursuant to the provisions of Section 2074.2 of the Fish and Game Code, the California Fish and Game Commission (Commission), at its April 15-16, 2020 teleconference meeting, accepted for consideration the petition submitted to list an evolutionarily significant unit (ESU) of mountain lions (*Puma concolor*) in southern and central coastal California as threatened or endangered under the California Endangered Species Act.

Pursuant to subdivision (e)(2) of Section 2074.2 of the Fish and Game Code, the Commission determined that the amount of information contained in the petition, when considered in light of the California Department of Fish and Wildlife's (Department) written evaluation report, the comments received, and the remainder of the administrative record, would lead a reasonable person to conclude there is a substantial possibility the requested listing could occur.

Based on that finding and the acceptance of the petition, the Commission is also providing notice that the Southern California/Central Coast ESU of mountain lions is a candidate species as defined by Section 2068 of the Fish and Game Code.

Within one year of the date of publication of this notice of findings, the Department shall submit a written report, pursuant to Section 2074.6 of the Fish and Game Code, indicating whether the petitioned action is warranted. Copies of the petition, as well as minutes of the April 15-16, 2020 Commission meeting, are on file and available for public review from Melissa Miller-Henson, Executive Director, California Fish and Game Commission, 1416 Ninth Street, Suite 1320, Sacramento, California 95814, phone (916) 653-4899.
