Dear Ms. Russell and Town Management,

The draft document states that the addition of more than 250 residences will have *no* impact on:

- -- Biological Resources
- -- Parks and Recreation
- -- Population/Housing
- -- Public Services
- -- Transportation
- -- Utilities/Service Systems
- -- and, most egregiously, Wildfire!
- ...and only minimal impact on:
- -- Air quality
- -- Cultural Sources
- -- Geology/Soils
- -- Greenhouse Gas Emissions
- -- Hazards and Hazardous Materials
- -- Noise
- -- Tribal Cultural Resouces

I'm gobsmacked. Let's take one example. The report says that the additional homes will have **no** impact on wildfire danger in our town. First, that is simply untrue: Several wildfire experts have weighed in on that fact, and several recent wildfires have demonstrated that housing density can contribute to rapid fire spread. Yet the document doesn't even acknowledge that fact. For reasons I do not understand, Town Management and the Town Council continue to classify houses and cars as potential fuel sources in the event of a wildfire.

Second, as I understand it, if we don't identify an impact, we cannot request assistance to mitigate it. Continuing with the wildfire example, mitigation could involve widening the shoulders of Alpine and Portola Roads, thus doubling the outbound traffic during an evacuation. The Town might be able to secure funding for that project *if we identify wildfire as a factor of significant negative impact.*

There's another, admittedly optimistic, reason for filing an accurate Mitigated Negative Declaration, rather than this inaccurate and cursory document. In eight years, when the next housing cycle begins, the Town will be on record *in this cycle* that several factors render our town ill-equipped to implement a significant increase in our housing stock.
