REMOTE MEETING COVID-19 MEETING ADVISORY: On September 16, 2021, the Governor signed AB 361, amending the Ralph M. Brown Act (Brown Act) to allow legislative bodies to continue to meet virtually during the present public health emergency. AB 361 is an urgency bill which goes into effect on October 1, 2021. The bill extends the teleconference procedures authorized in Executive Order N-29-20, which expired on September 30, 2021, during the current COVID-19 pandemic and allows future teleconference procedures under limited circumstances defined in the bill.

SPECIAL GEOLOGIC SAFETY COMMITTEE MEETING TOWN OF PORTOLA VALLEY 11 May 2022

Chairman Chester Wrucke called the meeting to order at 1900 [in Italy; 1000 PDT]. Laura Russell [town manager] determining quorum at 1902 [in Italy; 1002 PDT]

Purpose of Meeting:

The committee met to hear presentations by the UPP & APS consultants hired by the town to update the Town Safety Element, in particular to discuss draft subsections regarding geologic, seismic, and flooding hazards.

Old Business:

- Chet opened meeting to anyone wanting to address the committee about items not on the agenda.
- Minutes of the meeting of the Committee on 11 March 2022 were approved by the committee with one revision [Danna Breen not a council member].

New Business:

- Chet explained the focus of the meeting is the draft safety element.
- Carla Violet [UPP] summarized which policies and actions in the geologic safety subsection of the pending Safety Element have been updated.
 - Questions from the panel regarding whether renovated structures will fall within new regulations; new UPP landslide susceptibility map.
- Meeting opened to public questions at 1923 [in Italy; 1023 PDT]
- Committee members and residents asked questions about: enforcement provisions; lack of resilience of town infrastructure such as phone landlines, electricity; older trees falling on power lines.

Questions concerning why Hermit fault was removed from town geologic map in 2017; whether new landslides are included on maps.

Request that changes to any safety element be highlighted and dated.

Request from Nan that town's geologic data and reports be available to committee members. Reminder from Gary Ernst that earthquake faulting not quantitatively predictable. Nan emphasized the need to link geologic hazard policies and actions with those within the emergency management subsection.
