HYBRID MEETING

REMOTE MEETING COVID-19 MEETING ADVISORY: On September 16, 2021, the Governor signed AB 361, amending the Ralph M. Brown Act (Brown Act) to allow legislative bodies to continue to meet virtually during the present public health emergency. AB 361 is an urgency bill which goes into effect on October 1, 2021. The bill extends the teleconference procedures authorized in Executive Order N-29-20, which expired on September 30, 2021, during the current COVID-19 pandemic and allows future teleconference procedures under limited circumstances defined in the bill.

2. ORAL COMMUNICATIONS FOR ITEMS NOT ON THE AGENDA

3. APPROVAL OF MINUTES:

- 10/13/2022 via Zoom
- Jerrie Welch moved to approve the minutes and Heidi Kandall seconded, followed by unanimous approval

4. NEW BUSINESS:

- a. Budget Review
 - We previously had received an email from Cindy Rodas that we had a budget shortfall of \$430.
 - However we subsequently learned that there was an amount of \$2500 for Town Picnic music that was erroneously billed to the CAC budget instead of Parks and Rec
 - In addition, we discovered that \$6000 in donations / sponsorships had not yet been received, so we contacted each the donors / sponsors and we should now have received the funds. However, we have not received definitive confirmation from the Town that the funds have been received.
 - Assuming that the funds have been received, our corrected balance should be: \$6000 + \$2500 - \$430 = \$8070
 - However Phil Barth still needs to submit expenses of \$1700
 - So the remaining balance will be \$8070 \$1700 = \$6370
 - Need to get confirmation from the Town
- b. Review of Movie Night
 - Tamara did the bulk of the work
 - Ryan and Jerrie in attendance
 - For next time we should advertise more and work to get the word out at the schools, choose an earlier date in the year, perhaps Summer.
- c. Planning for PV PALOOZA
 - Date: June 10, 2023
 - More bands anticipated this year, so might need quicker changeovers
 - i. Last time we had 1 hour performances with 30 min changeovers
 - ii. Maybe this time 45 min performances with 15 min changeovers
 - iii. Might also need a screening / selection process if too many bands
 - Berklee students from PV are showing interest
 - Need to create a spreadsheet with a task list
 - Greg Posten will do the sound for PV Palooza and Summer Concert Series
 - John sent emails to confirm the PV Palooza date with Parks & Rec, Spring Down Farm and the Church.

- Sue suggests local artists at PV PALOOZA idea positively accepted by the committee
- d. Planning for Summer Concert Series
 - Dates: July 13, August 17 and September 14, 2023
 - Need to send dates to Kari at the Town
 - Band selection will start soon John & Ryan (other CAC members can join the effort!)
 - Bands should be selected by the end of 2022
- e. Local artists collection and photography / archives Sue Chaput
 - Sue sent letter to the Town December 2021, no reply wishes to historically preserve collection
 - Create a screen with art / photos that can be seen from enclosed building
 - Start with photographs in community room at town center rotate them out
 - Sue will contact the Town for support
 - Work with Nancy Lund to go to archives
 - Jerrie offered to help
 - Phil suggests Precision Graphics for copy / mounting of photos
 - Discussion of walls to place photos / art at town center
