**REMOTE MEETING COVID-19 MEETING ADVISORY**: On September 16, 2021, the Governor signed AB 361, amending the Ralph M. Brown Act (Brown Act) to allow legislative bodies to continue to meet virtually during the present public health emergency. AB 361 is an urgency bill which goes into effect on October 1, 2021. The bill extends the teleconference procedures authorized in Executive Order N-29-20, which expired on September 30, 2021, during the current COVID-19 pandemic and allows future teleconference procedures under limited circumstances defined in the bill

    nets, which was approved by the Town. It requires some clearing and paving, the Town Public
    Works Dept will take care of this. Once this is completed, we can order the nets.

- Parks and Recreation Committee/Town Classes: No new information.
- **Hawthorns Property Planning**: Karen indicated there have been some informational meetings for the Public but the Town Advisory Committee has not yet met.
- Parks and Recreation Charter/Edit: Completed. Areas we discussed as possible initiatives/priorities for 2023 and beyond:
  - Better access to our information (court policy/reservations, field usage policy, etc.).
  - Make it easier for people to find answers to questions
  - Better community outreach
- Parks and Recreation Town Web Pages/Edit: Karen offered to take ownership for this. The first step

  procedures for Court usage.
