Emergency Preparedness Committee Regular Meeting Minutes 6 July 2023

- 1. 6July23 In-Person Meeting called to order by Pfau at 0801 am
- 2. Individual Roll Call taken and a quorum was established.
 - Lynn Eisberg, Chris Raanes, Jerry Shefren and Vic Schachter were not present. Vic Schachter participated

3. Oral Communications

- Pfau recognized Dave Howes for his many years of service to the EPC.
- Pfau welcomed new member Craig Heberer. EPC is fully staffed at 11 members
- Pfau welcomed newly appointed Fire Chief, Tom Cuschieri
- 4. <u>Motion to approve</u> **013June23 Special Meeting Minutes** was made and the Minutes were <u>approved unanimously</u> without changes.
- 5. Town Report (Howard Young)
 - Please see attachment to minutes for written response from Howard Young to agenda Items.
 - The EPC expressed concern over support to move the AM Radio.
 - Town Staff has no ability to contact Cell Tower providers. Committee will attempt to contact wireless providers.
 - Craig Taylor told the committee that he would need a definitive proposal on suggested signs and placement to take to other committees. The EPC will attempt to provide this
 - A discussion was held on efforts to remove dangerous trees in the Town ROW. Estimates are
 that this would cost \$1 million and is not in the town budget. An ad hoc subcommittee of
 Marianne Plunder, Bud Trapp, and Rob Younge was formed to investigate the possibility of
 funding mechanisms for this project.

6. WPV-CERT/WFPD Report (Brown/Cuschieri)

- Both Station 7 and Station 8 remodels are on schedule.
- WFPD will be training on a tabletop exercise for evacuation
- WFPD will be hiring 2 new Firefighters/paramedics. Captain tests will be in the fall.
- Zonehaven has been acquired by Gemini
- SMC Alert test has been delayed; working with DEM to reschedule

7. Evacuation Plan Review (Younge)

- The Evacuation Plan was unanimously approved by the committee.
- The committee unanimously approved a motion to send the Evacuation Plan to the Town Council
 with a request that the Council review and approve the Plan before September.
- The committee unanimously approved a motion to request that the Evacuation Plan be included in the Town Update published by Kari Chinn.

Hello Dale,

As we just discussed, unfortunately, due to workload, we have not been able to have any substantial updates. We have been working on the budget and daily operations. We prepared for a huge weekend event, fire mowing on trails and roads, and wrapping work items up for the end of the fiscal year such as trail repair. In the time frame you mentioned below of March-June, we have adopted a Housing Element, extended and also negotiating a Sheriffs contract, hired an Interim Town Attorney, new Clerk, prepared and adopted a budget. These are huge items.

We have many Committees that we are working with that also require attention. When I have worked together with other Chairs, I provided a verbal update that the Chair then passed on to the Committee, which they found perfectly acceptable. Under these circumstances, I was hoping that you would do this also as Chair or if you have time, include the update below on your agenda:

- Update on Backup for Town Internet (Cori Stocker): no update, staff is still in the process of looking at all options and details.
- AM Radio relocation back to Town Center (Howard Young): Still working on with Staff.
- Status of Backup Power on Wireless Base stations in Town (Howard Young): Checking with Building/Planning, they indicated contacts listed on permits are subcontractors. Still working on. Again, this is a State mandate you are asking staff to verify.

Although we want to satisfy requests, we must look at the Town as a whole and prioritize. If you feel the items above are priority over other Townwide items, I suggest that you work with the Council Liaison so the Council can direct staff and adjust other workload. One could interpret the agenda that staff is being requested to attend, however, you explained to me that was not the intent, that your intent was to list who was responsible but not require attendance. If you can explain that to the Committee at the meeting and provide the above update.

Also as discussed, you or staff will remove Corie's name off the agenda and replace with mine as we don't think it takes two staff members to update.

Placing staff on an agenda without agreement or consultation first creates difficulty, dictates staff's priorities, and schedule. I respectfully ask for your cooperation, understanding, and continued patience.

I know that this likely is not the answers you want to hear but I wanted to provide you with information to consider now and in the future.



WPV-CERT is the registered **Community Emergency Response Team (CERT)** that operates within the Woodside Fire Protection District (WFPD). It is a program built on a FEMA-approved standard curriculum. The national CERT program trains volunteers to prepare for the types of disasters that their community may face











Through hands-on practice and realistic exercises, CERT members:

- Learn how to safely respond to manmade and natural disasters
- Help organize basic disaster response
- Promote preparedness within their communities

Radio Communications Status (details: radio.rothrockfamily.com)


- 1. Repeaters and AM: as of this report all radios/repeaters fully functional
 - a. AM Radio (AM, WRML513). Operational at 100% power.
 i. Still at Granada. See below.
 - b. PVARC (KM6DLG) amateur repeaters 2m/220/6m fully operational.
 - c. NVN (FM WB5NVN) amateur analog repeater fully operational.
 - d. NVN (DMR WB5NVN) amateur digital repeater fully operational.
 - e. San Mateo Sheriff's (f.k.a. OES) (KC6ULT) UHF link fully operational.
 - f. WPV-CERT Portola Valley GMRS (WQBS772) repeaters (PV1, PV2) fully operational.
 - g. WPV-CERT Easter Cross WD1 repeater fully operational.
 - h. LTW/VV GMRS (FM) repeaters are fully operational.
 - . CERT Easter Cross (Woodside) and Granada (Portola Valley) DMR repeaters operational. Microwave link operational.

Reached out this month to WPV-CERT to complete DMR to DMR repeater digital connection.

- 2. Communications Trailer.
 - a. Ready to go.
- 3. Town Hall EOC Equipment Status.
 - No action since May meeting.
 Need a conclusion about the needs of the EOC communications equipment.

4. AM Radio.

- a. As reported at the July '23 EPC meeting, Town concluded to move AM to town location and use Town antenna. EPC indicated that the impinging tree needs deep trimming if not complete removal. See photo below.
- b. Upgrading the current Town antenna to the HPR antenna (at 56 Granada) will require a lot of work and preparation but is not required for immediate relo.
- 5. MESH Network. SCARES (South County Amateur Radio Emergency Services) is participating in a larger Bay Area AREDN. Main local sponsor is Larry Sweeney, W6RMF.
 - a. https://www.sfwem.net See attached map.
 - b. Purpose: this is a radio based Internet substitute. It is not connected to the greater Internet but has the same capability as the greater Internet should the main Internet be down during an emergency.
 - c. Several sites in PV are now operational. More to come.





This location is at the southwest corner of the parking lot by Town Hall. This tree was not present when the antenna was originally located. The bulk of the tree covers the top of the mast and the base of the antenna. It will severely impair the performance of any antenna at this location.

Subsequent to this installation and when the AM was located at the Granada site, the Town purchased an upgraded antenna system, HPR-9000. The HPR needs to be moved to this location but is not required to be immediately moved to enable AM transmission from Town Hall.

Steps.

- 1. Trim or remove tree limbs around the antenna. Prefer removal of tree to reduce maintenance and any potential impairment to performance.
- 2. Relo the AM transmitter to Town and energize this antenna.
- 3. Update Town Internet system to allow programming and uploading of the AM radio audio tracks. This should happen when transmitter is relocated.
- 4. File with the FCC the new location of the transmitter. Uncontroversial.
- 5. Evaluate attaching HPR to this mast. It will require some attachment hardware (locally available), some people lifting equipment (scissor jack platform), and a small team of people to handle the installation.
- 6. Tune the HPR for this location
