 - i. Minutes approved (4/0), with correction of the typo of the library card.

6. OLD BUSINESS:

- a. Updates from Brandi
 - i. Smart Water Meters AMI Pilot Project with Cal Water
 - 1. Expect to install 2500. Have replace 658, most in Los Trancos plus the Ranch. Currently in Westridge, Golden Hills. Thanks to feedback from Loverine Taylor, they are providing further training to the installers. They have made a step-by-step guide on how to access the online system. It takes 7-10 days from the time of install until the website account is active. Still waiting for retrofit parts for customers with Flume. They prefer that folks switch to the AMR meter for \$50 refund. Brandi working with Kari to update the website to include information about Eye on Water and how to use the information being collected.
 - Rebecca committed to check the Water Efficiency section of the website
 and help update it with the smart meter and include Cal Water's new
 information about EyeOnWater. We might want to create a postcard or
 further information on the use of the analytics.
 - 3. Scott to work on the website to check for bad links.
 - ii. Greenwaste interactions, tour planning, HEA insert in future Greenwaste mailings
 - Looking for October dates, tour capacity limit of only 10 people with headsets.
 - iii. Climate Action Plan 2030
 - 1. On hold due to staffing issues
 - SB 1383 State's Climate Pollutant Reduction Strategy targeting organic waste disposal and surplus food.
 - Completed our electronic report. A grant allowed us to participate in a
 compost procurement program to meet the target and provided the
 compost to agricultural facilities and for the fields. Brandi to contact
 Webb Ranch and Wheeler Farms about certification. Need to encourage
 residents with large landscaping projects to use SB1383 compliant
 compost. (Lyngso and Greenwaste). Need to start a voluntary process
 for residents to use the compost and submit their receipts to the Town for

- tracking. Website to be updated with more information about the food waste regulations and compost.
- 2. Green Waste: construction waste and disposal without the tracking program. Brandi to see about more info for recycling construction waste.

 - We have the budget for the Lomi, unclear for the e-bike. We need to talk to the Town Attorney about liability issues.

 - iii. Brandi to check with Town Manager about the Town Attorney request.
 - iv. Anita when she gets back to order and create an info brochure for the Lomi. Scott to work on the liability waiver.
 - v. Request from Kristi Corley for Town to contact with Truckee about borrowing bikes and their legal language.
- d. Plans to develop a resource list (people, devices, demonstration locations) for sustainability in PV, including heat pump, heat pump water heater, induction stove, native and or drought resistant garden, net zero house, passive house windows, sustainable construction, home solar and battery, small scale solar and battery, smart electrical panel, various EV models, plant-based eating.
 - No response from the residents except two members from the Sustainability Committee to act as "experts" on various sustainability issues.
