We are waiting on his update on what the committee needs to take on in the absence.) Can any items be joint with Woodside or other small communities? Can the SC coordinate with Woodside SC.
  - i. Smart Water Meters AMI Pilot Project with CalWater key element for the SC. How should the SC continue to advance that roll out?
  - ii. Greenwaste interactions, tour planning, HEA insert in future Greenwaste mailings can the SC directly contact GW about the tour.
  - iii. Climate Action Plan 2030 key element for the SC.
     Needs to be approved by the Town Council first before we could take the lead on it. SC needs to get a copy of the rough draft and a copy of a model CAP.
  - iv. SB 1383 State's Climate Pollutant Reduction Strategy targeting organic waste disposal and surplus food.

member houses? Can we coordinate with East Palo Alto library? Backup power unit borrowed once a month. Attempt to add third item to library. Garrett leaving.

  - Response from Town nearly nonexistent of people willing to be "experts" (only SC members)
  - ii. Are there homeowners interested in opening their home and sharing their sustainability items in the house?
