Parks and Recreation Committee Meeting Minutes

Call to Order: The meeting was called to order at 7:33 PM

Roll Call: Members present - Patty Dewes, Dave Bailey, Karen Askey, Lindsay Bowen, Cindy

Rowe. This represents a quorum. **Members absent**: Jon Myers **Approval of Minutes**: Minutes were approved unanimously.

Oral Communications: None

New Business: None

Old Business:

- **a. Zotts to Tots/Town Picnic Saturday, September 21st**: Will start to ramp up our planning. We will ask Kari to put a "Save the Date" in the Town communications. Still looking at options on how a 60th Town anniversary celebration might fit into the picnic.
- b. Game night: Cindy got some quotes on vendors providing casino (blackjack, poker) night services. The full-service vendors (provide all materials including dealers) can be pricey. Given the Town's financial situation, we should plan on self-funding the event with an entry fee and minimizing the cost (i.e. providing our own materials and dealers). Also, we are considering bingo as a more family-oriented event. Will continue to look at options.
- **c. Hawthorns Planning**. Next PAWG meeting is the end of June, where it is anticipated that a decision will be made about the parking lot and entryway.
- **d. Town Courts:** Corte Madera tennis team has started practices and is using courts #2/3 with no issues. Waiting until spring to re-paint the All Sports (#3) court.
- **e. Dog Park**: Karen got some info about off-leash areas in San Mateo County. We agreed that the next step will be to get some community feedback and potentially move towards a pilot proposal. Karen/Patty will meet offline to discuss next steps.
- **f. Bocce Court**: Public Works gave us some feedback about this idea. The space we thought about (where the horseshoe pit is) is too small (a bocce court is about twice the size of the horseshoe pit) and is in an area with a lot of gopher activity and under trees. We'll continue to look at options.
- g. Parkland and Recreational Facility Dedication: The proposal has been submitted to the Town Manager with a request that it be added to the agenda for a future Town Council meeting.
- h. PV Recreational Facilities Opportunities: Patty & Carolyn Vertongen agreed to talk offline about the status of the Woodside Priory reciprocity agreement with the Town and possibility of updating it.
- i. CA State Grant: Howard indicated that the deadline has been extended to June. Jon feels that we should not give up on the idea of bathrooms at Ford Field and that we should pursue the grant as well as solicit additional funding from Little League, Susan Ford, etc. Patty will talk to Howard about this.
- **j.** Parking at Rossotti's/Ford Field: Questions about the status of these two financial agreements have come up at the Finance Committee. Parks and Rec has no jurisdiction here other than to ensure that parking is available to users of our recreational facilities. This continues to be an issue for Rossotti's field. Dave talked to Little League reps who

told him that there have been no issues with parking at Ford Field. We will continue to monitor and encourage the Town to renegotiate the Rossotti's Field parking lease to provide adequate and reserved parking for the soccer field.

- 2. Howard: Get status on 1) Court #3 repainting, 2) Ford Field bathrooms.
- 3. Sharif: Get status on Rossotti's parking lease renegotiation.
- 4. Kari: Add Zotts to Tots/Town Picnic "save the date" to Town Communications.
