2. Oral Communications:

- C. Vertongen asked if Conservation is still a Brown Act committee (answer: yes). She asked if Conservation is working with Trails and ASCC as joint committees for the review of new projects. C. Magill stated this had been proposed at one time but nothing has moved forward. C.
- Vertongen was requested to send an email to C. Magill clarifying her question.
- **3. Approval of Minutes for March 26, 2024:** The minutes were approved unanimously with one clarification/correction.

4. Site Permits

- a. 127 Pinon complete; report submitted. N. Chiariello suggested Conservation may want to specifically look for the presence of dittrichia during site visits, call out if present as both an invasive and a fire danger, and possibly request an additional site inspection a year after the final permit inspection to ensure dittrichia has been removed (add to the existing site visit boilerplate).

- i. Town Center Weeds have become prolific. M. Richards asked when the subcommittee leads will be able to meet with H. Young to go over the budget and prioritize next steps and projects.
