1. **11JUL24 Special In-Person Meeting** was called to Order by C. Raanes, Chair, at 0802.

2. **Roll Call** was taken and a **quorum** was established.

5. **Review/Create EPC plans to recommend Emergency Response protocol and planning**

- C. Heberer added to subcommittee
- Chair not elected
- No feedback from Town at present. Chair Raanes mentioned there is firm buy in from the Town Manager "When do we open EOC and what do we do when we get a phone call about a situation"
- Discussion
 - Original EOP does not factor in CERT
 - Make sure plan meets needs of community
 - Subcommittee meet with Town Manager and go through the process
 - Include PV radio station for mass communications
 - Include existing software program for remote EOC
 - Make sure plan has clear responsibilities
 - Practice the protocol
 - Include SMC Alert
- Next Steps
 - Chair Raanes and Subcommittee meet with Town Manager
 - Move forward together

6. **WPV-CERT/READY/WFPD Report (Giuliacci/Cuschieri)**

Giuliacci Report:

- Home Assessments; slow start; 123 completed in Zone 1-4; communication with residents is challenging; procedure is to walk property with resident gaining legal access
- June: completed 70 construction inspections, 50 plan reviews, contracted out 120 reviews
- N5 Sensor installation delayed; expected mid-August; 13 sensors for our district, 12 for Palo Alto, 25 for Stanford including placements on Jasper Ridge
- Ladris and FlameMapper merged; creating 4 YouTube fire scenarios for residents to watch; showing fire response-fire growth-traffic impact-etc.
- Encourage residents to download genasys app to receive notices faster than SMCAAlert
- Chipping Program is very well utilized by residents; Station 19 is in compliance with new Code; Team has been clear cutting in right-of-ways
- Westridge newest Firewise Group
- Assisted with June 3 Menlo Park fire; sent investigators to assist and followup; Firefighter Rehab trailer deployed
- Quarterly newsletter available on website; "e-subscribe" subscription in process
- Planning PV Evacuation Drill for May 2025; working on drill outline; includes resident participation; based on 1 of the 4 YouTube scenarios; Woodside Drill scheduled for May 2026
- Working to update WFPD signage
- Car seat installation program a huge success; dates on website
- Monthly new grandparent training also a huge success; dates on website
- Received Measure K funding for family first aid kits; kits to be distributed to newly trained CERTs as an incentive and thank you
- Fire District Family Open House (not public) well celebrated

Cuschieri Report:

- Strike Team currently deployed to a wildfire
- Stations #7 & #8 have completed construction and Final Inspections
- Planning an upcoming Community Open House

Radio Communications Status (details: radio.rothrockfamily.com)

1. Repeaters and AM: as of this report – all radios/repeaters fully functional
 - a. AM Radio (AM, WRML513). Operational. See below.
 - b. PVARC (KM6DLG) amateur repeaters – 2m/220/6m – fully operational.
 - c. NVN (FM WB5NVN) amateur analog repeater fully operational.
 - d. NVN (DMR WB5NVN) amateur digital repeater fully operational.
 - e. San Mateo Sheriff's (f.k.a. OES) (KC6ULT) UHF link - fully operational.
 - f. WPV-CERT Portola Valley GMRS (WQBS772) repeaters (PV1, PV2) - fully operational.
 - g. WPV-CERT Easter Cross WD1 repeater – fully operational.
 - h. LTW/VV GMRS (FM) repeaters are fully operational.
 - i. CERT Easter Cross (Woodside) and Granada (Portola Valley) DMR repeaters operational. Microwave link and repeater co-transmission operational.

2. Emergency Communications Trailer.
 - a. Ready to go. Trailer is located at Station 8.

3. Town Hall EOC Equipment Status.
 - a. Bluetti 2 KWhr power supply for all radios, AM operational and on timer recharging.
 - b. All radios are working, antennas tested well, batteries replaced 10/1/23
 - c. Starlink up and operational.

4. AM Radio. Operational but with a concern
 - a. **LAN for programming not yet complete. Request complete with Town IT.**
 - b. Week of Aug 19, AM transmitter blew a fuse. Internet transmissions continued.
 - i. Finding no electrical issues with the radio itself suspected an antenna issue because the Internet was still transmitting.
 - ii. Discovered the antenna has an intermittent connectivity issue causing transmitter overload.
 - iii. Inspected all connections, and matching network as best we could with a 12' ladder – all good.
 - iv. Issue is likely a connection between the four elements of the antenna.
 - c. **Recommendation: Procure a bucket truck capable of 20' and disassemble the antenna piece meal. Reassemble with better electrical connections including conductive paste and hardline connections between the elements.**
