THE CHIPPER PROGRAM

What is the Chipper Program?

The Chipper Program is a free hazardous fuel reduction program to help decrease our community's threat from wildfire. With a grant from Fireman's Fund, Woodside Fire purchased a wood chipper, which is used to chip vegetation removed by homeowners. The goal is to assist residents in creating defensible space around their homes.

How can I participate?

All we ask is you stack your material along the roadside (following the guidelines). Your neighborhood will be assigned a designated day when chipping will take place. No need to sign up.

Who will do the chipping?

The chipping is conducted by WFPD & Ben Lomond Camp inmate crews.

Stacking Requirements:


- Cut ends out facing street
- Pile no larger than 10' x 6'

Size and stacking procedures?

Vegetation should be piled along the roadside with cut ends facing towards street. Please limit pile to 10'x 6'. Material will be chipped back onto site where appropriate.

Please do not obstruct the roadway when stacking your material

What can be chipped?

Brush & tree limbs up to 8". Material can not contain nails, screws or wire as it can damage the chipper.

The chipper cannot chip Eucalyptus bark, vines or poison oak
