Old Business:

Update from Maryann:

Summary from CCAG meeting:

A professor from Stanford discussed sustainable urban water supplies. Santa Clara County is purifying non-potable water at its Silicon Valley Advanced Water Purification Center. LA has an old landfill that is being converted to wetlands and

a park. This will aid in recharging ground water. Large volume water storage is a difficult problem, so the ground needs to be our rain barrel.

Summary from BAWSCA:

Nicole Sandkulla gave a talk. Hetchy Hetchy is in good shape currently. We won't know about water conservation restrictions being lifted until May. Bear Gulch was only district that missed its conservation target (just barely). One of the most successful programs is rain barrels. It doesn't really save that much water, but it builds engagement and involvement in conservation.

Update from Howard:

Waste water from Portola Valley is pumped to the sewage treatment plant in Redwood Shores on Radio road. In PV, the guideline on sewer vs. septic is that if you have nearby access to a sewer line, then you must hook in when doing new building. The Town Council may reconsider this. The West Bay Sanitary District is moving forward with a water recycling plant for the Sharon Heights golf course

Report back on Water Conservation Events (Showcase and Water Awards):

Judy: Special grass seed mix only needs watering once or twice a summer (Pearl's Premium grass seed mix). Perhaps put in a fourth test plot at town center:.

Flow Meters – Droplet has not ramped up manufacturing yet. If this really gets going, we should help promote it. Projected price is less than \$100, more if web based.

Brandi – update on her meeting with Cal Water (Dawn) and Jeremy – Smart meters will have to be justified to the CPUC before there can be a big program to install them. Maybe we can help with the justification. Redwood City and Purissima Hills both are installing smart meters. Cal Water is supposedly moving forward with installation of endpoint meters. As a committee, we have more to learn on the differences between smart meters and endpoint meters. PV water conservation data for Jan and Feb: We used 5.3% more water in Jan16 relative to Jan13. We used 25.7% less water in Feb16 vs Feb13. This leaves us with a cumulative savings of 39.1% for the Jun15 thru Feb16 period (vs. the goal of 36% and Bear Gulch total of 35.6%).
