 - b. Bev Lipman requests our help educating a neighbor who has a huge patch of thistle growing. Unclear how Town wants us to handle such requests. Murphy will talk with Town Manager to get some clarity.
 - c. Bourne Nancy Reyering who was a guest attending our meeting last month wrote a note expressing admiration for how we conduct our business and appreciation to the Town for working so closely with us.
