One item being considered is how far wells should be set back from streams. Existing regulations are more focused on protecting wells rather than protecting creeks. #### **New Business:**

### **Distribution of Committee Postcards:**

Jeremy distributed Committee postcards to all attendees. They are for outreach and contact with residents. Let the town staff know if we run out.

## **Discussion of Town Regulations with Jeremy:**

Discussion of process: as the committee comes up with ideas for next fiscal year, provide recommendations to the Town Council of potential areas to work on. That lets the Town Council provide feedback before too much effort is expended. It also gives the town staff a chance to review our ideas. The approach should be to bring to the Council

the idea of an area to work on first, rather than with a specific, fully formed recommendation. Try to get ideas fleshed out prior to budget setting in June.

# **Discussion of Potential Voluntary Municipal Water Reduction with Jeremy:**

The state is allowing a change in the water conservation target from 36% to 10%. What should the town do to support the conservation target? Specifically, what should we do with the town fields? Brandi provided an extensive presentation of data on how the fields are currently maintained and their expected condition under differing watering scenarios. She will send the data out to committee members.

We need to conserve at least 10%, but even at that level fields will likely be stressed. So manage the fields so that they are as good as possible while still saving 10%. Long term there may be more of a role for technology and rainwater catchment in helping adapt to reduced water availability.

# **Debrief from Smart Irrigation Controller Workshop**

Good turnout – 34 attendees. Some comments from committee members who attended:

- possibly too basic
- Lori (the workshop leader) may have emphasized her favorite controller too much
- the intro may have been too long

Maryann brought up that debugging issues with Smart Irrigation Controllers can be problematic – may be a little too complicated for many residents. One suggestion was to perhaps sponsor some local peer user groups to help out others with the same brand of smart controller.

We need to try and do more to have qualified, trained contractors who can work with residents. Lori's handout at the workshop had some information on water wise certification. Discuss further in Smart Irrigation Subcommittee
